




Update

- In regular contact with CE Highways (Aki Tsakonas) on the speed issue
- Meeting held May 2024 set out initial plan of work:-
 - Achieved more detailed understanding of how limits are decided, why there was no response to the report submitted to highways by the 'Speeding sub Group), etc.
 - Anomaly between Peckforton and neighbouring Beeston, Bunbury and Spurstow acknowledged.
 - Speed Monitoring agreed.
 - Jointly (with community) revisit the Priortisation Matrix which determines whether Highways will pay for the necessary speed control measures, signs etc.
- Speed monitoring through centre of village completed June 2024
- Meeting held February 2025
 - Further review of Speed Monitoring data from 2024 and 2022 carried out in conjunction with Highways.
 - Detailed discussion on how we move thing forward

Speed Monitoring Locations



Speed Monitoring Results Stone House Lane

- 2024 Data
 - Location Village Centre
 - +/- 680 vehicle movements per day
 - Average speed = 24.5 mph
 - 85th percentile = 30 mph
 - Max speed observed 5 vehicles in range 60-65 mph
- Data Supports 40 mph limit

- 2022 Data
 - Location StoneHouse Lane
 - +/- 450 vehicle movements per day
 - Average Speed = 27 mph
 - 85th percentile = 35 mph

Data Supports 40 mph limit

Speed Monitoring Results Peckforton Hall Lane

- 2022 Data
 - Location Peckforton Hall Lane
 - +/- 300 vehicle movements per day
 - Average Speed = 31.5 mph
 - 85th percentile = 37.5 mph
- Data Supports 40 mph limit

The 85th percentile speed is the speed at or below which 85 percent of the drivers travel on a road segment. Motorists traveling above the 85th percentile speed are considered to be exceeding the safe and reasonable speed for road and traffic conditions.

Key Issues

- Both Cheshire East
- Peckforton 60 mph, Spurstow 40 mph
- Housing density higher in Peckforton
- All other factors broadly similar

Other Anomalies

- Beeston 40 mph and 30 mph
- A49 through Bunbury 30mph
- Peckforton Hall Lane (Spurstow) 30mph
- Whole raft of inconsistencies with Cheshire East's 'Speed Management Strategy Document' and the situation in Peckforton

Current Situation

- Anomaly between Peckforton and neighbouring Parishes acknowledged
- Speed monitoring data supports 40 mph limit
- CEH (Aki Tsakonas), believes Police would support 40 mph limit
 - If 30 mph then they have to proactively 'police' it
- Cost to install signs etc. est'd at +/- £20,000 (source CE Highways)
- Parish income +/- £3,200 pa. of which > 50% goes on administration and legal costs
 - (Clerk fees, insurances, website maintenance, compueter licences etc. etc.)


To obtain CE Funding we need to score higher on the Prioritisation Matrix

Current Score 37 .. Needs to be > 55 and ideally > 60 for Highways to fund it.

- In practice.....


We have an opportunity!



A more detailed look at the Prioritisation Matrix

- Score as determined by CE Highways March 2023 (in isolation of the community) 37
- Anomalies/items to question
 - Level of Pedestrian activity Score 3 (medium)
 - Can we argue high and score 5 -> Net +2 (we're on the Sandstone Trail)
 - Is this a residential area Score zero
 - Yes = 5, No = 0. I would argue this and data from Spurstow comparison supports this.
 Net +5
 - How many Tourist Attractions or Leisure Facilities are in close proximity Score 1
 - Assessment assumed 1 to 3. Could we argue more...
 - Elephant & Castle, Sandstone Trail, Peckforton Castle, on route to Beeston Castle, Village Hall, ... If we get 4 or more then Net +1
 - Neighbourhood Engagement Other Organisations (e.g. Resident associations, Speed Watch Groups – Score zero
 - What about Village Hall Committee, the Peckforton Speeding & Highways Subgroup...
 We scored zero, If we get just one then we score Net +5

And the BIG ONE ... Local Concern




Number of recorded resident and/or stakeholder concerns for vulnerable road user safety on CONFIRM? (In Past 3 Years)

Current score Zero

1-2 we score 5

> 3 we score 10

And the BIG ONE ... Local Concern



Do more than half of the recorded concerns above reference traffic speeds causing social issues

Current score Zero

> If answer is 'yes' we score ANOTHER 10

What to Report

• Any items of concern relating to road safety where you feel a speeding vehicle created a dangerous situation.

Examples

- 'I was waiting with children for school bus on Peckforton Hall Lane. A car came
 past me so fast I had to push my children into the hedge' to protect them from
 being hit. I do feel that the 60-mph speed through Peckforton Village is
 dangerous and should be reduced.
- I was out running along Stonehouse Lane and a vehicle went past me at high speed narrowly missing me. There is no pavement on Stonehouse Lane, and there was nowhere for me to go to get out of the way. I would ask that CE Highways give serious consideration to reducing the speed limit through Peckforton Village.
